- ✓ Pod kvalitativnim kriterijem relevantnosti dodano: *Prijedlog je relevantan za poštovanje i promicanje zajedničkih vrijednosti EU-a, kao što su poštovanje ljudskog dostojanstva, slobode, demokracije, ravnopravnosti, vladavine prava i poštovanje ljudskih prava te suzbijanje svih oblika diskriminacije*

The ECHE Principles

THE INSTITUTION UNDERTAKES TO

1. Respect in full the principles of non-discrimination, transparency and inclusion set out in the Erasmus+ Programme.
2. Ensure equal and equitable access and opportunities to current and prospective participants from all backgrounds, paying particular attention to the inclusion of those with fewer opportunities.
3. Ensure full automatic recognition of all credits (based on the European Credit Transfer and Accumulation System – ECTS) gained for learning outcomes satisfactorily achieved during a period of study/training abroad. Including during blended mobility.
4. Charge no fees, in the case of credit mobility, to incoming mobile students for tuition, registration, examinations or access to laboratory and library facilities.
5. Ensure the quality of the mobility activities and of the cooperation projects throughout the application and implementation phases.
6. Implement the priorities of the Erasmus+ Programme:
 - a) By undertaking the necessary steps to implement digital mobility management in line with the technical standards of the European Student Card Initiative.
 - b) By promoting environmentally friendly practices in all activities related to the Programme.
 - c) By encouraging the participation of individuals with fewer opportunities in the Programme.
 - d) By promoting civic engagement and encouraging students and staff to get involved as active citizens before, during and after their participation in a mobility activity or cooperation project.

WHEN PARTICIPATING IN MOBILITY ACTIVITIES

Before mobility

7. Ensure that selection procedures for mobility activities are fair, transparent, coherent and documented.
8. Publish and regularly update the course catalogue on the website well in advance of the mobility periods, so as to be transparent to all parties and allow mobile students to make well-informed choices about the courses they will follow.
9. Publish and regularly update information on the grading system used and grade distribution tables for all study programmes. Ensure that students receive clear and transparent information on recognition and grade conversion procedures.
10. Carry out mobility for the purpose of studying and teaching only within the framework of prior agreements between institutions which establish the respective roles and responsibilities of the parties, as well as their commitment to shared quality criteria in the selection, preparation, reception, support and integration of mobile participants.
11. Ensure that outgoing mobile participants are well prepared for their activities abroad, including blended mobility, by undertaking activities to achieve the necessary level of linguistic proficiency and develop their intercultural competences.
12. Ensure that student and staff mobility is based on a learning agreement for students and a mobility agreement for staff, validated in advance between the sending and receiving institutions or enterprises and the mobile participants.
13. Provide active support to incoming mobile participants throughout the process of finding accommodation.
14. Provide assistance related to obtaining visas, when required, for incoming and outgoing mobile participants.
15. Provide assistance related to obtaining insurance, when required, for incoming and outgoing mobile participants.
16. Ensure that students are aware of their rights and obligations as defined in the Erasmus Student Charter.

During mobility

17. Ensure equal academic treatment and the quality of services for incoming students.
18. Promote measures that ensure the safety of outgoing and incoming mobile participants.
19. Provide appropriate mentoring and support arrangements for mobile participants, including for those pursuing blended mobility.
20. Integrate incoming mobile participants into the wider student community and in the institution's everyday life. Encourage them to act as ambassadors of the Erasmus+ Programme and share their mobility experience.
21. Provide appropriate language support to incoming mobile participants.

After mobility

22. Provide incoming mobile students and their sending institutions with transcripts of records containing a full, accurate and timely record of their achievements at the end of the mobility period.
23. Ensure that all ECTS credits gained for learning outcomes satisfactorily achieved during a period of study/training abroad, including during blended mobility, are fully and automatically recognised as agreed in the learning agreement and confirmed by the transcript of records/training certificate; transfer those credits without delay into the student's records, count them towards the student's degree without any additional work or assessment of the student and make them traceable in the student's transcript of records and the Diploma Supplement.
24. Ensure the inclusion of satisfactorily completed study and/or traineeship mobility activities in the final record of student achievements (the Diploma Supplement).
25. Encourage and support mobile participants upon return to act as ambassadors of the Erasmus+ Programme, promote the benefits of mobility and actively engage in building alumni communities.
26. Ensure that staff is given recognition for their teaching and training activities undertaken during the mobility period, based on a mobility agreement and in line with the institutional strategy.

WHEN PARTICIPATING IN EUROPEAN AND INTERNATIONAL COOPERATION PROJECTS

27. Ensure that cooperation activities contribute towards the fulfilment of the institutional strategy.
28. Promote the opportunities offered by the cooperation projects and provide relevant support to staff and students interested in participating in these activities throughout the application and implementation phase.
29. Ensure that cooperation activities lead to sustainable outcomes and that their impact benefits all partners.
30. Encourage peer-learning activities and exploit the results of the projects in a way that will maximise their impact on individuals, other participating institutions and the wider academic community.

FOR THE PURPOSES OF IMPLEMENTATION AND MONITORING

31. Ensure that the long-term institutional strategy and its relevance to the objectives and priorities of the Erasmus+ Programme are described in the Erasmus Policy Statement.
32. Ensure that the principles of the Charter are well communicated and are applied by staff at all levels of the institution.
33. Make use of the ECHE Guidelines and of the ECHE Self-assessment to ensure the full implementation of the principles of this Charter.
34. Regularly promote activities supported by the Erasmus+ Programme, along with their results.
35. Display this Charter and the related Erasmus Policy Statement prominently on the Institution's website and on all other relevant channels.

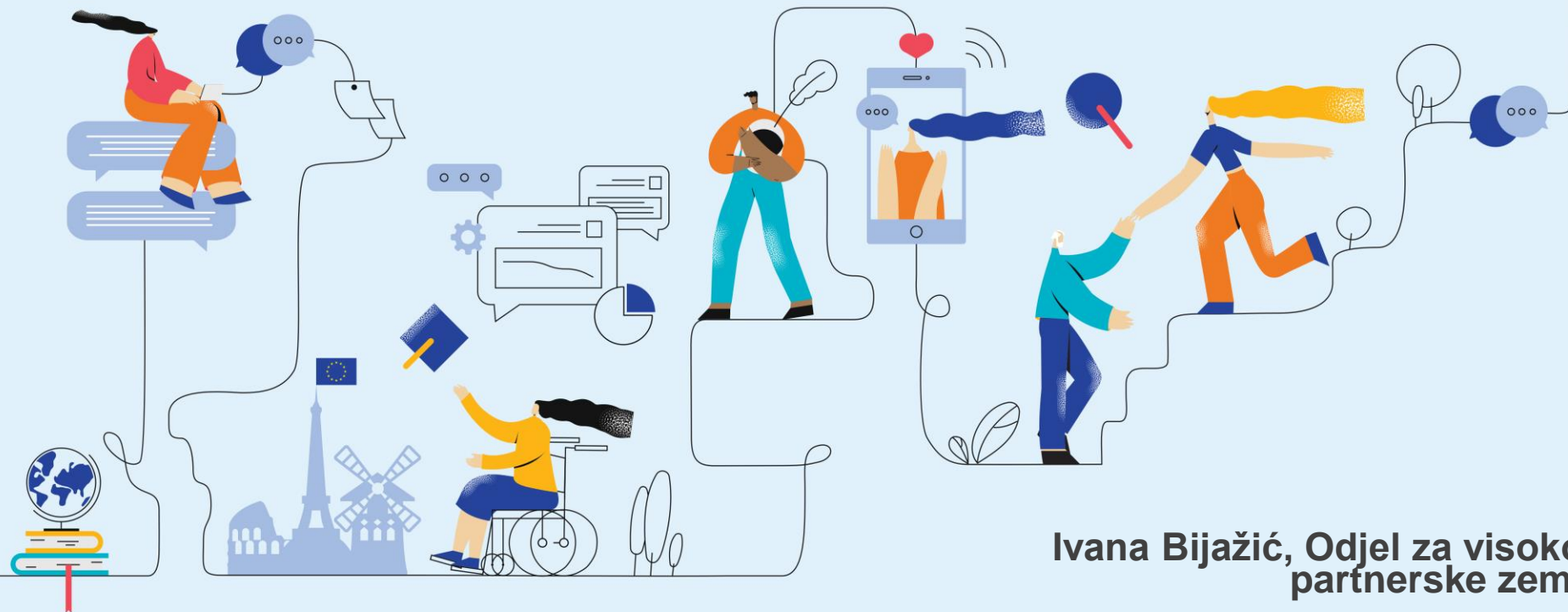

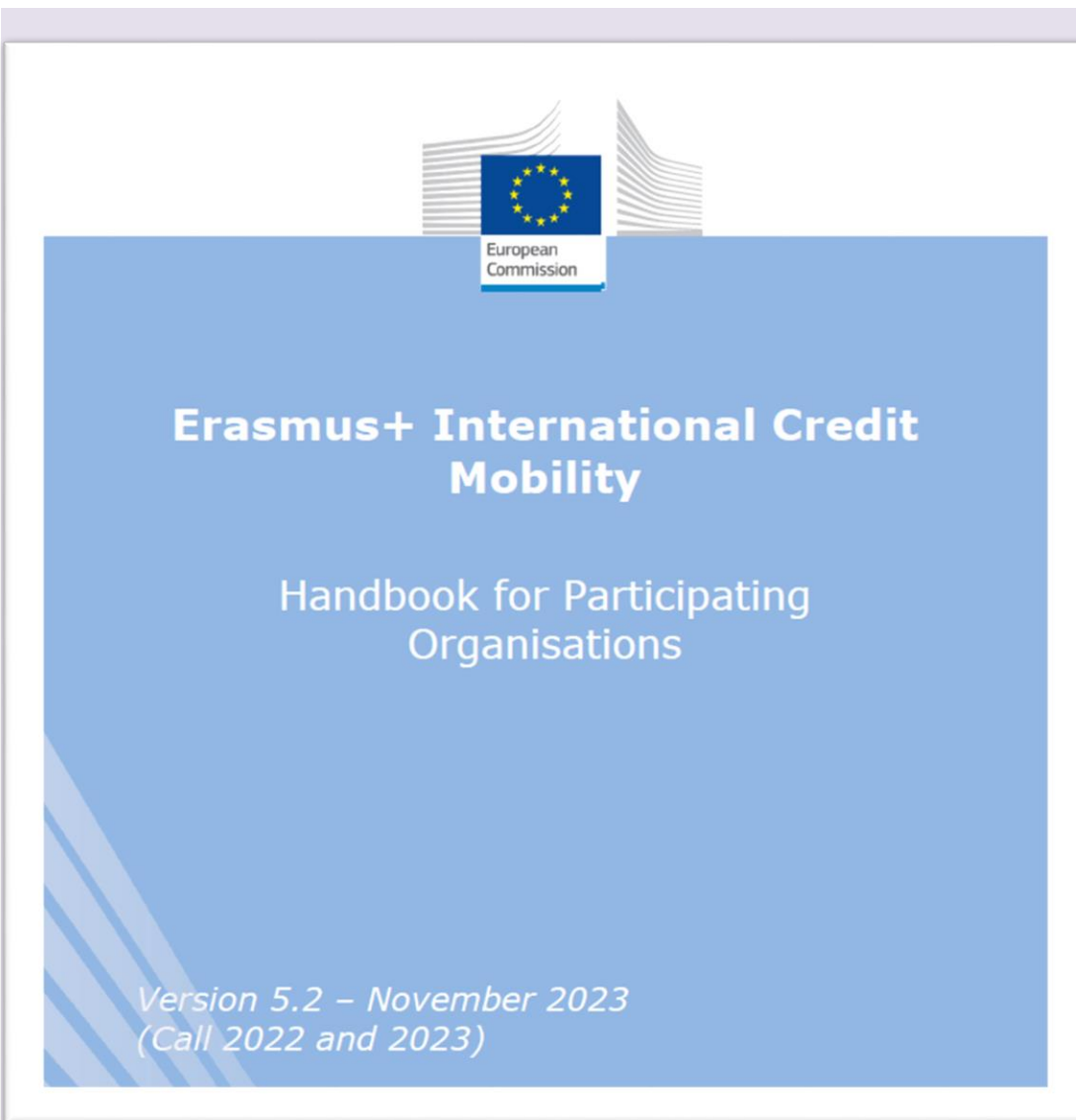

OGRANIČENJA ZA ODLAZNE STUDENTSKE MOBILNOSTI NIŽIH RAZINA STUDIJA



Due to the requirement to contribute to the objectives of the EU external action, mobilities for short-, first- and second cycle students carried out with countries eligible for official development assistance (ODA)⁵⁵ in regions 2-11 are limited to incoming mobility from third countries not associated to the Programme. Outgoing mobility towards these regions is only available for students at doctoral level and for staff.

If the applicant has been awarded a mobility project supported by internal policy funds, the aforementioned non-eligible international outgoing mobility flows to these regions may be funded in a complementary way by this mobility project supported by internal policy funds.

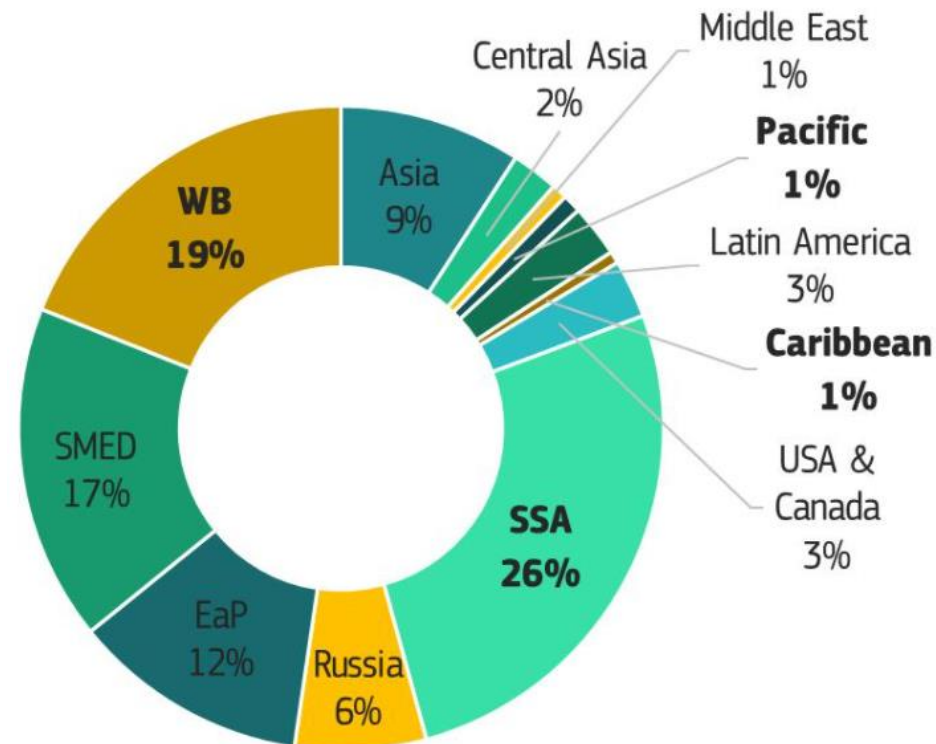

Europska komisija propisala je prioritete do kraja programskoga razdoblja:



Asia:

- A minimum of 25% of the budget should be spent on mobility with the least developed countries (LDCs) of the region;
- No more than 25% of the budget should be spent on mobility with the High Income Countries (HICs) of the region;
- No more than 15% of the budget should be spent on mobility with China;
- No more than 10% of the budget should be spent on mobility with India.

▪ **Pacific:**

- No more than 86.5 % of the budget should be spent on mobility with Australia and New Zealand together.

▪ **Sub-Saharan Africa:**

- A minimum of 35% of the budget should be spent on mobility with the least developed countries (LDCs) of the region, with a special emphasis on migration priority countries;
- no more than 8% of the budget should be spent on mobility with any country.

▪ **Latin America:**

- No more than 30 % of the budget should be spent on mobility with Brazil and Mexico together.

▪ **Eastern Partnership:**

- A minimum of 40% of the budget should be allocated to students with fewer opportunities.

▪ **Southern Neighbourhood:**

- No more than 15% of the budget should be spent on mobility with any country;
- A minimum of 65% of the funds should be allocated to students, 50% of whom should be with fewer opportunities.

▪ **Western Balkans:** emphasis should be on student mobility.

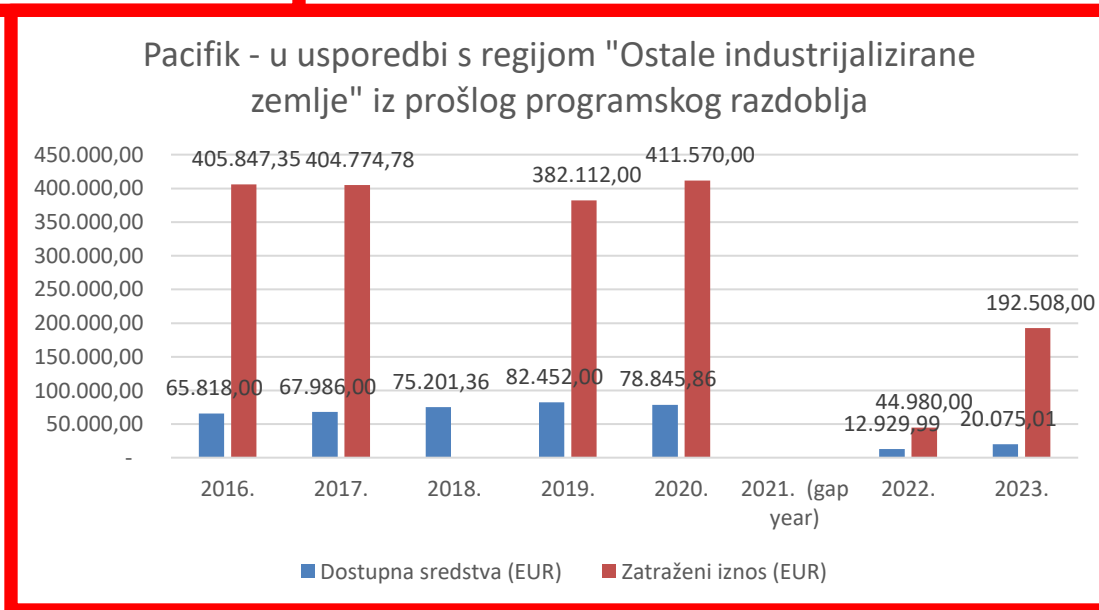
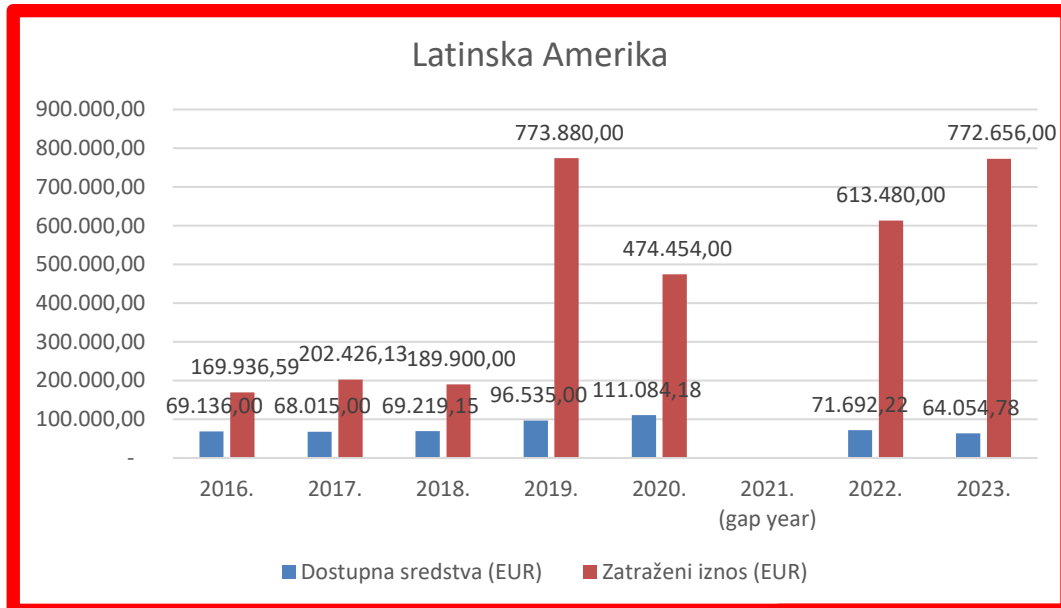

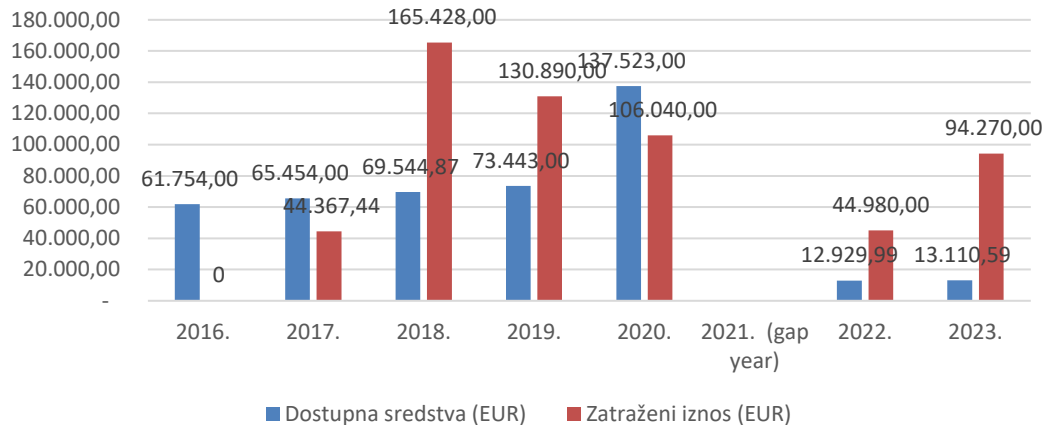

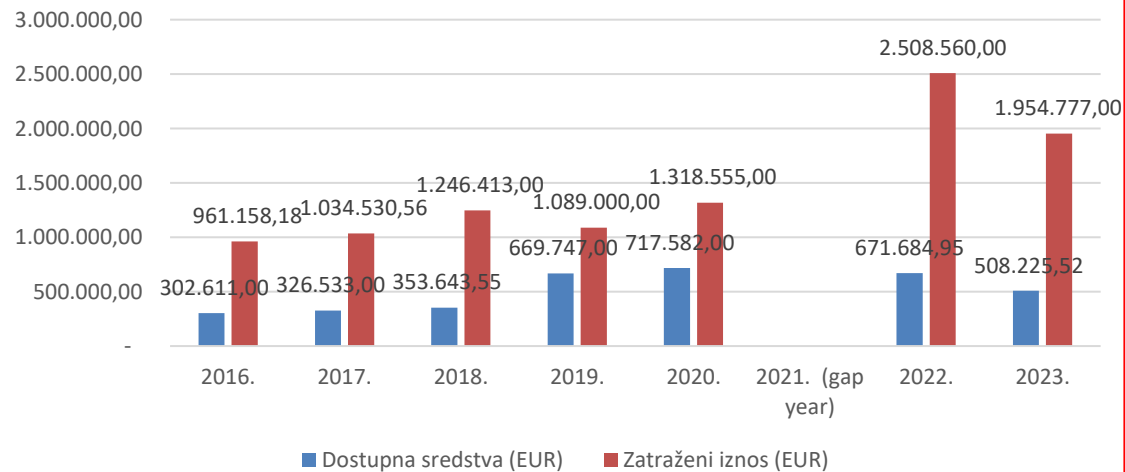

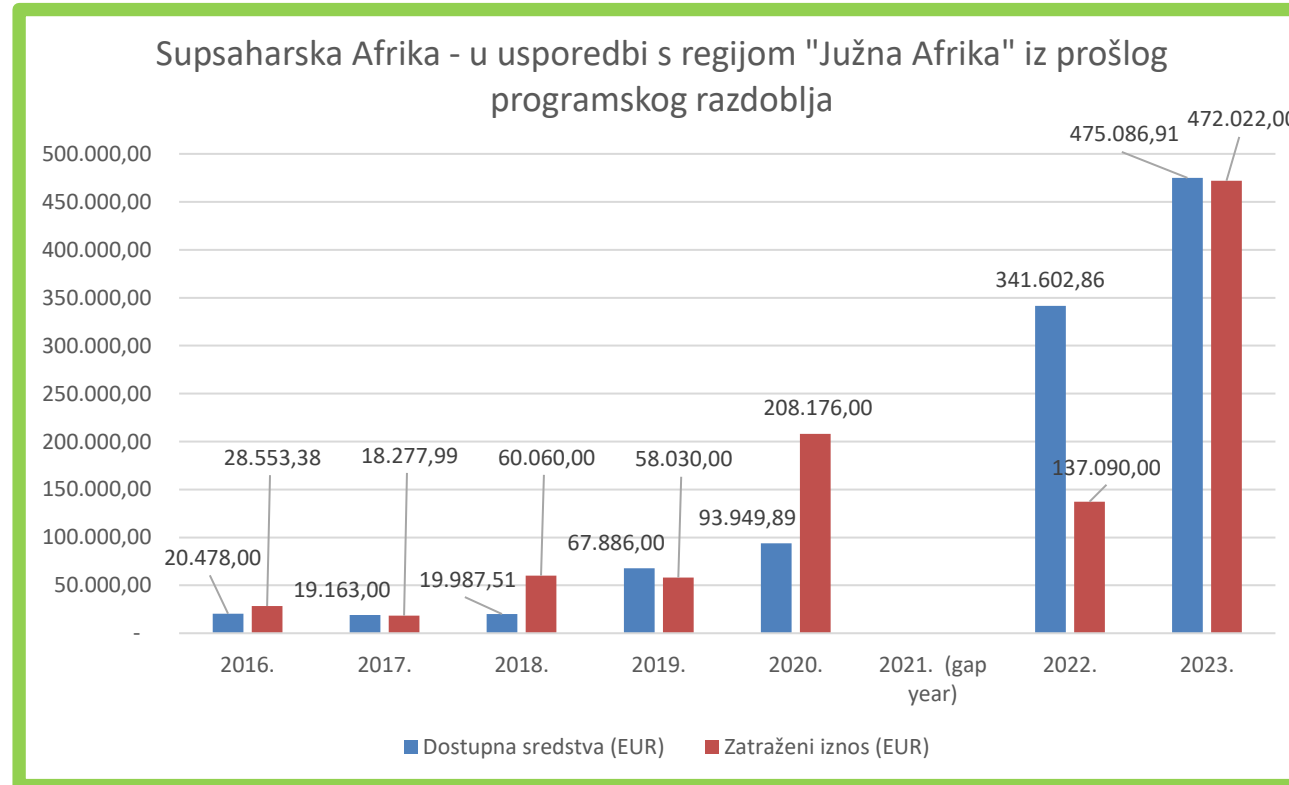
Karibi - u usporedbi s regijom "ACP" iz prošlog programskog razdoblja

Provjera raspona udaljenosti

- potrebno je detaljno provjeriti zatražene udaljenosti za željena visoka učilišta

Zatraživanje dodatka za studente i nedavno diplomirane s manje mogućnosti

- zatražiti dodatak u slučaju ukrajinskih studenata

Zatraživanje kratkoročnih mobilnosti

- budući da u alatu nije predviđena funkcionalnost za zaseban izračun kratkoročnih mobilnosti i ne sadrži jedinične troškove za istu, kratkoročne mobilnosti moguće je zatražiti isključivo u okviru jediničnih troškova na mjesečnoj bazi

- kratkoročne mobilnosti u fazi prijave potrebno planirati i potraživati kroz broj sudionika i mjeseci, a prema iznosu pojedinačne potpore koji će za njihovo financiranje

Regarding learner mobility flows, the requested EU grant is calculated on the basis of the monthly rate for long-term learner mobility. If the applicant would like to plan short-term blended mobility as well, they should reflect the necessary grant for these short-term mobilities in a number of monthly rates and not insert the equivalent in duration (e.g. one monthly rate of long-term mobility is not sufficient to fund 30 days of short-term blended mobility).

Example for calculating short-term mobility grant

To plan 6 incoming learner mobilities : 2 long-term (each for 5 months) and 4 short-term mobilities (each for 20 days), calculation of the individual support would be:

- $2 \times 800 \text{ EUR} \times 5 = 8\,000 \text{ EUR}$
- $4 \times 14 \times 70 \text{ EUR} + 4 \times 6 \times 50 \text{ EUR} = 5\,120 \text{ EUR}$

For the long-term, applicant fills in 2 mobilities for 10 months.
For the short-term mobilities, applicant should request $5\,120/800 = 6,4$ months (rounded upwards to 7 months to ensure enough funding).

In total, 6 mobilities for 17 months are encoded.

Dodijeljeni iznos financijskih sredstava ovisi o:

- ostvarenom broju bodova u kvalitativnom dijelu
- broju i trajanju prijavljenih mobilnosti
- dostupnome proračunu za odgovarajuću regiju
- geografskoj ravnoteži unutar odgovarajuće regije



- nema garancije kontinuiteta financiranja na temelju uspješne prethodne provedbe, ne koristi se *past performance* faktor u alokaciji
- bez obzira na ostvareni broj bodova, Nacionalna agencija može dati prednost mobilnostima s određenim zemljama u svrhu osiguravanja geografske ravnoteže unutar regije sukladno prioritetima EK
- Dodatni kriteriji prihvatljivosti koje određuju nacionalne agencije:

Where the budget envelope for a particular partner region is limited, a National Agency may choose to add one or more eligibility criteria from the list below:

- Limiting the degree level for participants (for example limiting applications to one or two cycles only – bachelor, master or doctoral level);
- Limiting the type of participants to staff or students only;
- Limiting the duration of mobility periods (for example limiting student mobility to 6 months, or limiting staff mobility to 10 days).

In the event that a National Agency decides to use these additional eligibility criteria for the projects, this decision will be communicated in advance of the applications submission deadline, in particular on the National Agency's website.
